## 1. Background information

FoSaMed is an international project co-financed by the European Commission within the framework of capacity building in the field of higher education, key action 2 of the Erasmus + program (Capacity Building in the field of Higher Education). The duration of the project is 3 years from January 15, 2021.

#### Objectives of the project

FoSaMed aims to bring together Moroccan HEIs that promote inclusive education through curriculum development and teacher education on food safety.

The main specific objective of the project is the development of a joint Master's Programme, within the curricula of the IAV, ENA, IBN and UMP that will receive the support of the project coordinator the University of Évora (UEVORA) together with the University of Barcelona (UB) and the Mediterranean Universities Union (UNIMED).

The specific objectives of the FoSaMed project include the qualification of the Moroccan academics on modern and innovative teaching methodologies, to support Moroccan HEIs in designing a Master Programme on food safety that is associated with the recovery and promotion of the traditional Mediterranean diet and associated to short food supply chains, and to contribute to inclusive higher education in Morocco, that integrates underprivileged groups, such as women, rural populations and refugees and gives them equal access to knowledge and the opportunities it brings.



The following actions will be developed in order to develop innovative pedagogical approaches and new learning settings:

- a) An innovative e-learning training for food safety coordinated by EU partners, using didactic modules and integrated tools.
- b) Workshops coordinated by UEVORA and UB to enhance the quality of the teaching methods.
- c) The development of a MOOC (Massive Open Online Course) about "Food safety in Morocco".
- d) The implementation of a Joint Master's Programme on food safety run by the involved Moroccan HEIs, which will be the key focus of the FoSaMed project.

### 2. Scope of the External Evaluation

The objective of the external evaluation is to assess the progress and success of the activities of the different WPs aligned with the project indicators and to propose actions to improve the overall effectiveness of the results. The evaluator/expert will analyze and interpret data on the project to identify achievement of results and weaknesses, document the status of the project in reports and make recommendations.

The external evaluation will cover the following elements:

- Performance of the partnership;
- Achievement of set objectives;
- Effectiveness and impact of activities and main deliverables;
- Identification, preventive measure and corrective measure of risks;
- Impact of the project activities at the national level (Morocco);

The external expert will be responsible for:

- defining quality indicators for each element to be evaluated and monitoring procedures;
- the design and submission of questionnaires and grids to assess the progress of the project;
- data collection and analysis;
- cooperation with the WP Leader (ENA) and the Management Committee (MC) for integration of results;
- the preparation of evaluation reports according to a schedule set by the evaluation committee.

Reports are generated to indicate the progress of the project and to offer recommendations.



More specifically, the evaluation should:

- Highlight what has been successful and can be replicated elsewhere;
- Indicate shortcomings and constraints in the implementation of the project while, at the same time, identifying the remaining challenges, gaps and needs for future courses of action;

In particular, the evaluator should include recommendations on:

- Subsequent actions needed to improve the effectiveness of the project logframe;
- other actions conducive to ensuring successful attainment of the expected accomplishments of the project.

The results of the evaluation will be shared and discussed within the project Management Committee during its meetings.

- Documents supporting the candidate's CV: experience/professional competence/expertise, etc. (ex: Diplomas, certificates, attestations, etc.);
- Declaration of availability for the entire period of the project;
- Reference projects;
- A concept note with a draft methodology proposed for the evaluation (2 pages maximum);
- A financial proposal for the execution of the tasks

Fluency in the English language is required. Knowledge of French language are essential.

Proposals must be written in English. Any incomplete file will not be evaluated.

For reasons of neutrality, the candidate cannot belong to one of the member universities of the project.

#### 7. Selection criteria

Applicants must meet the following conditions:

- A higher education diploma, preferably in the field of Educational Sciences;
- Have in-depth knowledge of the functioning of higher education system, pedagogy, implementation of training activities and international cooperation;
- Have already participated in external evaluations and contributed to studies on quality assurance;
- Have experience in evaluating capacity building/training projects in the Euro-Mediterranean area within the thematic scope of food studies or food safety;
- Fluency in oral and written English, knowledge of French and fluency in at least one of the other official languages of the project partner countries (Portuguese, Spanish, Italian or Arabic)

The criteria for the selection of candidates are:

- Clarity and relevance of the concept note on the methodology of the project evaluation: 20%
- In-depth knowledge of the functioning of higher education system, pedagogy, training activities and international cooperation (20%)
- Prior contribution to one or more studies on external evaluation and quality assurance: 15%
- -Professional experience and reference projects in the Euro-Mediterranean region in the thematic area of food studies or food safety (10%)
- Linguistic skills (15%)
- Financial proposal: (20%)

## 8. Validation and evaluation process





Candidates will be selected on the basis of the above evaluation process.

Please note that any application will receive a response at the end of the recruitment process by University of Évora (UEVORA) and by Ecole Nationale D'Agriculture de Meknes (ENA) as project coordinator and leader of the WP-Quality Evaluation, respectively. The expert will then be selected by the Management Committee (MC).

## 9. Budget

A maximum budget of 13,500€ (euro) has been allocated for this evaluation activity. It is recalled that the travel and accommodation expenses for participation in the meetings and activities foreseen in the work plan will be covered by this budget.

## 10. Payment schedule

Payments will be made on the basis of invoices sent by the expert and on presentation of the activity report, as follows:

- 20% upon signature of the contract;
- 50% upon submission of the first report;
- 30% at the end of the project and submission of the final evaluation report.
